General customer information about RoHS Directive 2011/65/EU ("RoHS 2.0") and extension of restricted substances by Directive 2015/863 ("RoHS 3.0")

All SICK products are developed and manufactured according to the applicable regulations. Since 2006, SICK has been developing all new products in a fully RoHS-compliant manner and has therefore been actively promoting the transition to RoHS conformity since its early stages.

SICK products are classified in **Category 3** (IT and telecommunications equipment), **Category 9** (industrial monitoring and control instruments) and to **Category 11** (other EEE).

The transition of all SICK products that fall within the scope of the RoHS Directive has been completed by the mandatory deadline. Consequently, none of the products that we deliver to you contain any substances which may not be placed on the market pursuant to the RoHS Directive 2011/65/EU and the delegatet directive EU 2015/863. This information is based on information provided from third parties and a verification procedure.

SICK AG has introduced a verification procedure to assure compliance with legal obligations on substance restrictions pursuant to the European RoHS Directive [2011/65/EU]. The verification procedure meets the requirements of the harmonized standard IEC 63000. This verification procedure includes chemical analyses of annual samples to minimize risk.


