GENERAL PRINCIPLES

Such assessments also include the consideration of ergonomics in the selection and provision of work equipment and machinery.

Employees become personally involved in occupational health and safety through their active participation in training programmes, which teach the safe operation of equipment and machinery and the desired outcomes of the required administrative measures.

Our well-established emergency management system enables us to respond appropriately to hazardous incidents. In the event of an accident or close-call, as well as in the case of critical events, systematized follow-up assessments are carried out to define preventive protective measures.

The Executive Board, senior management and works council (where applicable) collaborate to implement and promote holistic and comprehensive systems for health and safety.

INFORMATION SECURITY & DATA PROTECTION

The appropriate protection of our information and business processes ensures the independence of our company. With regards to information security, the appropriate protection of our information in terms of confidentiality, integrity, and availability, we follow the internationally recognized ISO 27001 standard and the associated ISO 27002 controls.

We are aware of the special responsibility when dealing with personal data. Therefore, it is a matter of course for us to comply with the applicable laws and regulations on data protection.
